President's Report

Sally Fitzpatrick

2009-2010

As it was in '08-'09, so it continued in '09-'10.

The dilemma about Service Models, 24 hour staffing, SAAP funding.

The major problem still is that SAAP/DoCS do not recognise the necessity of 24/7 staffing for medium-long term youth accommodation services and suggest that this need should be met (by which they mean funded) by Out of Home Care.

Paper shuffling by government departments. However, there are NO GENDER SPECIFIC OUT-OF-HOME-CARE SERVICES, and the expressed need of most of our referrals is for "girls only".

There is a very real threat that our funding will be seriously reduced next year as they refuse to



acknowledge the reality that there are many young women who need a lot more than a few months training in "living skills" to prepare for independence. Lillian's is known for the nurturance that allows the girls to grow up at their own rate and holds them safely until they reach that maturity - in the knowledge that it is not chronological and may take much longer than the SAAP-promoted 18 months maximum. We get referrals from all over the state looking for placements for girls who, for various reasons, are better placed in a female living environment.

We had waited for years for DoH to do something about the fire danger of the upstairs room that we could not use as a bedroom. Finally, after checking with City of Sydney about requirements, we went ahead with the installation of security doors which cannot be opened from the outside, but are easily opened from the inside in the event of fire. These were very expensive but provide both



security and safety. This meant that we were able to convert the computer/rec. room into a fifth bedroom and increase the number of residents. We plan to move the office into the staff bedroom and create another bedroom. There were discussions around the possibility of using this sixth bedroom as an emergency bed to attract the 24/7 funding, or

physically dividing the two large upstairs rooms and making the house 8 bedrooms (the residents were appalled at that idea - wouldn't all fit in the car, or even around the dining table).

After many meetings, going in circles, it was decided to hire a consultant to clarify our options and help to decide on our future model of service: and that is now in process.

Thanks to all the staff and to my fellow committee members.




Treasurer's Report

Patti Nicholson

2008-2009

A much smaller surplus this year as we spent a lot of money on security doors/ fire safety and made provision for setting up new bedrooms. This accounted for nearly \$40,000.

Our staffing expenses were down by about \$4,000 as we continued to employ only according to need, and until the number of residents increases there is no perceived need to increase staffing levels, but we expect this change in the next financial year as we employ double cover after school to cope with the complexity of multiple appointments of five or six residents.



"How can I trust your information when you're using such outdated technology?"

The anticipated rise in the cost of electricity resulted in an increase of about \$500 this year, and we expect it to get worse. This is a major reason, along with ecological concerns for the fate of the planet, that we applied to use some of accrued surplus to install solar panels on the roof. With the size of our roof and the back to the grid deals that existed at the time, the refuge would have been generating a considerable

amount of power and therefore money, which could have reduced our reliance on grants.

Permission denied!!

Hard to see the sense in that - again paper shuffling between departments (should come out of Housing money, not SAAP money - but it is all taxpayers money and would save the government in the longer term).

We forgot to include in the financial statements the value of the tutoring provided to our residents by Powdermonkey Social Alchemy. Three girls were individually tutored two or three times a week by professional tutors; this would have cost thousands of dollars if we had to pay for it and we give our sincere thanks to Chin-Liang Beh for this generous donation and also to the tutors for their support for the students.

Our thanks also to OzHarvest for food deliveries and again to Better Read Than Dead for their gifts of children's and young adults books - our library is now impressive and it is encouraging to see girls reading.

Food costs continue to rise and cost \$6,000 more than the previous year, despite OzHarvest contributions, as we choose the healthy options which are, sadly, more expensive.

Our provisions for all staff entitlements (annual and sick and long service leave) amount to nearly \$180,000 and are safely accrued.

The audited financial statements for 2009-2010 are attached to this report. Thanks to Cheryl Hastie, chartered accountant.

Our plans for the surplus have been discussed with DoCS and are currently on hold as we prepare for a Consultation/Review with the possibility of a new service model as the outcome, with probable establishment costs.

Exciting times.

Report on the financial report

The Management Committee's responsibility for the financial report

First the statistics so loved by mysterious, faceless number crunchers. In 2009-2010 the four beds were occupied 1,409 out of possible 1,460 nights which is a 96.51% occupancy rate. And this does not include the time that the bed is held while girls are on assessment.

Plus the support that Lillian's provided to H** and D** in their quest for independence, which is also not counted.

Well done Lillian's.

And for next year we will have an extra bedroom, possibly two.

In the financial year from July 2009 to June 2010

K*** flew for the first time - to Melbourne with her Art class, and performed in the Opera House twice, started root canal treatment , passed her School Certificate and began a series of immunisations because she was starting a nursing traineeship. Started year 11 and a VET course and tutoring with Social Alchemy in English and Biology.



D** and H** studied for their Higher School
Certificate exams and graduated from high school and went to the Year 12
Formal in fine style. They both produced incredible art work for their HSC which took a long time and a lot of effort. H** also graduated from her two year VET course with Certificate III in Health Services Assistance. D** applied for a place in the Music Theatre course at



Eora College, auditioned and was accepted. H** applied for a scholarship place in enrolled nursing at North Sydney TAFE and was chosen. After an incredible saga with Department of Housing to get a "T" number, eventually they moved together into a flat provided by Metro Housing. Lillian's continues to provide support.

M*** graduated to the next level in her TAFE course after working very hard and doing more homework than anyone else ever. Lillians found an ESL tutor who helped a bit, but all credit to M***. She attended the Granville Multi-cultural Girls' Group, had a tooth removed - and this was the biggest tooth root and tangled and took a long and gruelling time to extract - she was incredibly brave. In 2010 M*** started to get tutoring in English (Olivia) and science (Chin-Siang) from Social Alchemy, who also took her on outings during holidays.





S*** attended school more than she had been and graduated from the LEAPS programme and also the boat building work-education course. Rosemount offered a place in 2010 and this was a positive outcome. And at the end of February S*** was able to move to live with her grandmother and after a few months reclaimed Tweety (who we all had grown to love).

Counselling happened for several girls and added to their well-being, and we especially acknowledge Ilona from Headspace and Marc from STARTTS.

Cindy organised front row seats for the girls to watch Australian Idol. Tracey took them to see Bangarra's "Fire" at the Opera House. And Farah and Cindy took everyone for a holiday to the Blue Mountains to breathe fresh air, look into vast distances, listen to birdsong, explore the Jenolan Caves and generally have a jolly time.

Sadly for poor S***, she suffered a major allergic reaction to something and her body was covered in a swollen rash and medical help was sought. It spoiled her holiday.



Kylie took everyone to see Circus Oz and the opening night of "Bran Nue Day" while Farah found a Putt Putt course and also braved Movies at the Overflow.

Nicola and Farah led the zoo expedition.

Lillian's joined with some neighbours to start a Community

Garden in a vacant block of land on Erskineville Road and this is an ongoing project which is now supported by The Friends of Erskineville Village.

Staff members, all of whom are members of the ASU participated in several mass meetings and rallies for the cause of pay equity. This is



an ongoing campaign and has the support of the ALP and The

Greens, and will come before Fair Work Australia for arbitration early 2011.

We raised objections with Sydney City Council about the next door neighbour's large first floor deck which would overlook our middle courtyard and the girls' bedrooms - this was a year long battle which ended with a compromise, ensuring that nobody was happy.

Lillian's embarked on the long process of getting registration as a Community Housing Provider.

In February the dining room and kitchen and half the hallway were flooded with filthy, muddy water from the building site behind (where they built five townhouses in the little paddock that we had previously been able to access). DoH sent a water extractor to clean it up and we spoke to the building supervisor, but torrential rain happened again before they rectified the problem. The refuge was again flooded and this time we sought compensation. It was squishy and smelly for a while but steam cleaning helped. We used



the insurance money to buy new shutters for the lounge room to help with summer heat.

Ultimo TAFE again sent us a very good youth work student, thanks Nicola.

Our focus on education received a huge help this year thanks to Chin-Liang Beh and his tutoring school Powdermonkey Social Alchemy. Chin-Liang organised and set up a tutoring room at Glebe PCYC and offered free tutoring to any of our residents who would commit to following through with the help offered. This has really focussed the girls and staff



on the importance of the structured study time but these tutors also offered mentoring and social education, giving of their leisure time to take students on excursions to galleries, museums, the zoo and even the movies. Chin-Liang organised free gym membership at Sydney Uni and really encouraged a healthy lifestyle approach. Lillian's is truely grateful for the generous gift and wants to thank each of the tutors for their efforts.

Our Management Committee has had its work cut out for them this year with both the DoH audit and more particularly trying to sort out options for service models to make sure that Lillian's continues to receive ongoing adequate funding. Unless we get enough funding to operate 24/7 on site Lillian's as we have known it will be unable to continue. This is a milestone moment.



Thanks to Sally, Naomi, Patti, Ann, Athena and Barbara for their loyalty and dedication to the cause.

And the team. Cindy, Farah, Kylie and Tracey with Skye and Leah available in emergencies; and Monica, our supervisor. Thanks, as always, to you for your hard work and caring. The young women we work with deserve nothing less than the best nurturing support that we can give them.

"A letter about Lillian's

To whom it may concern,

I have been here for a little over one school term, although it truly does feel a lot less. Maybe because the day to day regime has become a lot less arduous thanks to the supportive workers. I've noticed at Lillian's that all workers have a gentle but firm approach to the overall running of the house, e.g. they are quite reasonable with curfews, chores etc.

Despite the mish-mash of backgrounds which brings forward newer concepts to me personally, it has been a liberating experience. I have enough freedom to accept and express myself but there are also the boundaries that remind me that there are people who care.

Cooking for the residents and workers alike is definitely an experience I savour. Going to plays and the beach is not something I expected for a women's refuge. It distracts the fact that I'm the most subtly more independent and doesn't force me to grow up at an uncomfortable rate.

Overall I can never truly express how much gratitude I have for the workers (Lin, Tracy, Cindy, Farrah, Skye and Kylie) for bringing more opportunities before me than I could even believe, and dealing with my eccentric behaviour and otherwise plain odd ideas.

They humour most of my tangents and that has contributed to shaping me as a whole.

At Lillian's i have also learnt awareness of nutrition, environmental sustainability, making lamb shanks and a lot more that could list in a separate letter.

Leaving home would have been a mistake for me but finding Lillian's gave me a choice, something that most tend to disregard. Lillian's is a sanctuary."


Dear All!
